**BRITISH MODEL FLYING ASSOCIATION (BMFA).** BMFA membership is mandatory for all OMFC members. If you are already a member of the BMFA, either as a Country Member or through another club, you will only need to pay the OMFC membership subscription. See SUBSCRIPTIONS.

**CLUB RULES.** The Club Rule Book is issued to all new members and copies are available on request. Every member must comply with the Club's rules. Members are required to act appropriately if they witness any practice that they consider dangerous or likely to bring the Club into disrepute, or which is in any way contrary to the Club rules, whether by a Club member or another person.

**JUNIOR MEMBERSHIP.** Junior (under 18 yrs) members participating in Club activities must be accompanied by a parent or legal guardian. An application from a Junior must be signed by a parent or legal guardian on his or her behalf, signifying agreement to the terms and conditions of the Club Rule Book.

**CAA REGISTRATION.** When flown outdoors, RC and Free-Flight Models weighing 250g or more must display a valid CAA Operator ID. When operating such models, members must hold a valid CAA Flyer ID, BMFA Registration Competency Certificate (RCC) or BMFA RC Achievement Scheme Certificate; copies of the appropriate documentation must be carried, or available electronically, and individual members are responsible for ensuring that they comply with the law. Senior members who are affiliated to the BMFA through OMFC may obtain a CAA Operator ID by applying to the Membership Secretary (see SUBSCRIPTIONS); however, all members must apply for a BMFA RCC (recommended) or CAA Flyer ID individually. Please note that a Junior member is not permitted to hold a CAA Operator ID; it is recommended that a parent or guardian should obtain one on the Junior's behalf.
